CURRENT/FUTURE RELEASES

The latest version of IATS 8.4.0 is now available and sites should be receiving it soon via mail or DoD Safe. Please reach out to the help desk to have it sent to you electronically. As a reminder, the DFAS provided Sybase license expired on September 30th and all sites should be migrating to MSSQL. If your agency has procured a Sybase license of your own, you may contact the IATS helpdesk for an updated Sybase version and rate updates for Sybase. This latest IATS version has many changes including policy changes, so it is imperative that you install it as soon as you receive it.

ALASKA TRANSPORTATION ALLOWANCE

In IATS version 8.4 there is a new order type called 'ALASKA LEAVE' based on the PDTAC MAP Item 16-23(R) which announced the JTR change. This order type will be used for Military members stationed in Alaska from December 22, 2022, through December 31, 2023. This new order type will only be available for selection of the Employee Status in the Traveler Profile is a member and only the reimbursables tab in the Entitlements tab should allow the examiner input for airfare and other associated expenses. This order type will allow supplementals to be performed in case a member files two separate claims for each leg of air travel. Late interest is payable for this order type if the expected payment date is more than 30 days from the date reviewed by the AO.

Reimbursable Expense not being taxed

If an original claim involving CBA Airfare was processed in IATS version 8.3 or older, and a supplemental is being processed in version 8.4 to add a reimbursable expense, it doesn't collect the taxes on the supplemental amount. This will be corrected as an SCR in IATS version 8.5. As a workaround, in 8.4, you can enter the claim as not a supplemental and it will tax it accordingly.

IATS Version 8.4

Version 8.4 was released the end of May 2023. Refer to the official IATS SCR 8.4 Document found on the DVD for more detailed information on each issue and the fix. Here's some of the enhancements included:
